**RE: Liquid Waste Transportation Permit Date Range System Change**

Dear Liquid Waste Hauler:

In effort to increase the efficiency of the City of Haltom City's Liquid Waste Program, the City is transitioning to a standardized permit date range system. **Effective April 01, 2021, all liquid waste transportation permits in the City of Haltom City will be valid from January 1 through the end of the calendar year, expiring on December 31, despite the date the permit application is received.** Haulers are encouraged to submit the annual renewal registration paperwork at the end of each calendar year to be eligible to service Haltom City within the full permit date range in the following year. A new permit number will be assigned each time a permit is issued.

## City of Haltom City Liquid Waste Program



### Requirement Checklist

Liquid waste haulers must be registered to operate in Haltom City. **Registration is valid for one year.** Below is the list of required items to be submitted with the permit application. The Operations Manager must acknowledge the requirements listed below by initiating next to each item. This list is not an inclusive of all the City of Haltom City requirements for Liquid Waste Transporters.

Initials	Requirement
_____	Completed trip tickets must be received by Environmental Services no later than the 10 <sup>th</sup> day of the month following the month of disposal.
_____	Completed trip tickets may be mailed or hand-delivered to the City of Haltom City Environmental Services at 4200 Hollis Street, Haltom City, TX 76111.
_____	All trip tickets can only be used to document the service of one single trap, tank, or interceptor.
_____	If present, sampling wells must be cleaned each time an interceptor is serviced.
_____	Copy of current, valid Driver's License must be on file with Environmental Services for any driver operating in Haltom City and must be submitted before the driver begins operating in the City.
_____	Proof of current, valid liability insurance must be on file for each vehicle permitted to operate in Haltom City and must be re-submitted each time a policy is renewed or updated.
_____	Copy of current SLUDGE Permit issued by the Texas Commission on Environmental Quality (TCEQ).
_____	Copy of most recent vehicle inspection ticket for each registered vehicle.
_____	All trip tickets used to document service at locations with multiple interceptors must have consistent, unique identifier for each interceptor.
_____	The servicing of any tank, trap, or interceptor in Haltom City must be documented on a "City of Haltom City Liquid Waste Transportation Trip Ticket" form.
_____	Failure to comply with any of the requirements, including those not listed above, will result in a code enforcement action, up to and including citations and permit revocation.
