



## CITY OF HALTOM CITY, TEXAS

### ALCOHOLIC BEVERAGE LICENSE/PERMIT APPLICATION

Pursuant to Haltom City Ordinance O-2004-006-01, no person shall sell alcoholic beverages in the City of Haltom City unless a permit/license is issued in conformance with all state and city regulations. To obtain a new license or to renew an existing license to sell alcoholic beverages within the city of Haltom City, a person **MUST submit the TABC permit/license packet and the city permit/license application to the City Secretary's office**. All forms must be completed and notarized as applicable. The business location will be verified for zoning through the Planning and Zoning Department and then Certified by the City Secretary. Upon receipt of an initial application, the City has 30 days to complete its review and determine whether to issue the permit.

#### Submittal Information and Requirements:

1. An applicant for alcoholic beverage permit must file a complete of Haltom City Alcoholic Beverage License/Permit Application with the City Secretary's Office.
2. A copy of the completed T.A.B.C. application form.
3. Copy of Applicant's Driver License.
4. Copy of Certificate of Occupancy.
5. Copy of an Alcohol Measurement Plat/ land survey map or a sketch or diagram showing the configuration of the premises. The survey map must determine if the place of business is located near any protected uses, or the application will not be considered.
6. **License/Permit Fees** – Make payable to the City of Haltom City. The Permit/License fees must be paid at the time of application and are non-refundable.
7. **State License/Permit** - Please contact the Texas Alcoholic Beverage Commission (T.A.B.C) at 817-652-5912 or 2225 East Randol Mill Road, Suite 200, Arlington, Texas 76011 to obtain forms and information to file for State License.

#### City Alcohol License/Permit Fees (Two-Year Fee)

The City is authorized by Ordinance No. O-2004-006-01 to collect a City fee for alcohol permits upon the establishment or renewal of the Texas Alcoholic Beverage Commission (TABC) license. City Fee are one-half of the state fee and will be collected in accordance with the Texas Alcoholic Beverage Code, Section 11.38. Please see the attached fee schedule for appropriate fee due.

**Requirements for Food and Beverage Certificate Holder**

- A menu or, if no menu is available, a listing of the food and beverages, including prices, offered for sale.
- Hours of operation for the sale and service of food are at least the same hours for the sale and service of alcoholic beverages. Food must be available at all times that alcohol is being served.
- Projected receipts from the sale of alcoholic beverages are 60% or less of the total gross receipts of the location.

- Records for food service will be made available for inspection or audit, even if the food service facility at the location is maintained by a separate business entity than the permittee.

I \_\_\_\_\_ understand that the Food Beverage Certificate and Alcoholic Beverage License/Permit may be cancelled at any time if the City of Haltom City finds that the location does not meet the eligibility requirements. I further understand that if the License/Permit is cancelled for such reason, I will be ineligible to apply for a new certificate until one calendar year has passed from the initial cancellation.
