Comes now the defendant in the above styled and numbered cause by mail or fax and do hereby plea Nolo Contendere (No Contest) to the said offense, waive my right to a jury trial, and would show the Court the following:

**1. I have included evidence of remedying the following defect within 20 working days after the date of the offense: (a separate motion must be submitted for each offense)**

\_\_\_\_ Expired Motor Vehicle Registration – \$20 dismissal fee applies  
**Your receipt for renewal (proof of correction) MUST show you paid the penalty fee**

\_\_\_\_ Operate vehicle without license plate or with only one OR with current registration insignia not attached  
\$10 dismissal fee applies

\_\_\_\_ Expired Drivers License - \$20 dismissal fee applies

\_\_\_\_ Fail to report change of address or name with DPS - \$20 dismissal fee applies

\_\_\_\_ Driver's License Restriction - \$10 dismissal fee applies

\_\_\_\_ Expired disabled parking placard that has been expired for 12 months or less - \$20 dismissal fee applies  
If it has been expired more than 12 months you must pay the fine in full.

**2. I have included evidence of valid insurance on the date of my citation**

\_\_\_\_ Financial Responsibility – no dismissal fee

**3. I have included a check, money order, or credit card payment form to pay the dismissal fee listed. I further understand that if I do not pay the correct fee, the insurance is not valid, the inspection or parking placard has been expired more than 12 months, or I did not pay the penalty fee for the registration, my violation will NOT be dismissed and a balance will remain that needs to be paid before a warrant is issued.
