## WAIVER OF TRIAL AND MOTION FOR DEFERRED DISPOSITION

## ORDER

It is ordered that the above motion be granted. Under the authority of Article 45.051 of the Code of Criminal Procedure, the court orders that the violation is deferred for a period of 90 days. The defendant is not to receive any other citations in any jurisdiction during the deferred period. The court accepts the bond that the defendant has posted.

If the defendant successfully complies with the conditions of this order, then this case shall be **DISMISSED** by the court and shall **NOT** be reported as a conviction, but a special expense fee in the amount of the bond posted above will be applied. Failure to comply shall cause this case to result in a **CONVICTION** and payment of a **FINE**, including court cost, in the amount of the bond and said bond will be used to pay the fine.
