- b. Detail of what the applicant proposed to install (pipe size, number of inter-ducts, valves, etc.)
- c. Detail of plans to remove and replace asphalt, concrete in the street, and using City Standards and Specifications.
- d. Drawings of any bores, trenches, hand holes, manholes, switchgear, transformers, pedestals, etc. (include depths).
- e. Hand hole and/or manhole typical of type of hand holes and /or manholes applicant plans to use or access.
- f. Complete legend of drawings, which may be provided by reference to documents previously submitted to the City.

- g. The construction and installation methods to be employed by the protections of existing structures, fixtures, and facilities within or adjacent to the right-of-way, and the estimated dates and times work will occur, all of which are subject to the reasonable approval of the Director of Public Works.
- h. A copy of any permit or approval issued by federal or state authorities for work in federal or state authorities for work in federal or state rights-of-way in the City.

5. Understand that work shall not begin until the following are complete:

- a. All other utility providers in the area have been given notice of the excavation, (i.e. a written record of the notification to the notification center).
- b. Occupants of property adjacent to the proposed work site must be notified.
- c. All signatures must be on permit applications and plans stamped approved by Public Works.
- d. 3'x 3' information sign, traffic barricades, arrow boards, etc. are in place.
- e. Erosion control measures on site.
- f. Contractor has on-site general notes, approved permits and plans.
- g. List of all contractors and/or subcontractor(s) who will perform work has been provided.

6. All construction to be in strict accordance with this permit, the City of Haltom City's Standard Details and Specifications, and Ordinance No. 0-2000-054-16, as amended.
